Government Coerced Leaders of Faith

Jim Thorp, MD, is an extensively published physician board-certified in obstetrics and gynecology, and a specialist in maternal-fetal medicine who has practiced obstetrics for over 42 years. Dr. Thorp shares the truth of unprecedented fetal deaths and miscarriages. His website, *Totality of Evidence*, provides resources for those wanting to know about vaccines, public health, and the “One World, One Health Agenda.”

Meticulous research by Dr. Thorp and his wife, Maggie Thorp, JD., shows that religion was used by the National Institutes of Health (NIH) and Health and Human Services (HHS) in an attempt to convince faith leaders around the country to push the COVID-19 injections. The Thorps’ “deep-dive into the organization *Faiths4Vaccines*—a founding member of the HHS’ vaccine-propaganda machine *COVID-19 Community Corps*—has revealed just that.”

The Thorps explain that “HHS began tapping faith leaders in the spring of 2021 to push the uptake of COVID-19 vaccines.” The “manner in which government officials persuaded these faith leaders to push the shots” was “inappropriate—if not unconstitutional.” The “faith leaders” category of the *COVID-19 Community Corps* numbered 86 founding members representing, for example, the American Baptist Church, Catholic Charities USA, the Episcopal Church, and the National Association of Evangelicals. The Thorps note it wasn’t “financial incentives that ultimately convinced faith leaders to push the COVID-19 vaccines on their members. Instead, it was a strategy that baselessly appealed to faith leaders’ deeply held moral and religious beliefs—targeting their virtues instead of their vices—and which shamelessly relied on religious doctrine and a pro-vaccine ‘theological’ interpretation to support pushing the shots.”

Faiths4Vaccines includes over 1000 faith leaders across the U.S. (A spin-off of *Faiths4Vaccines* is *Youth4Vaccines*.) The Thorps note that “it strives to ‘demonstrate religious communities’ trust in the vaccine.” The *Faiths4Vaccines* National Summit took place on May 26, 2021. The Thorps explain that it “was the largest religious summit of its kind to be held in the U.S. The summit included some 800 registered faith leaders, and also included public health and U.S. government officials. Its purpose? To increase COVID-19 vaccination uptake, reduce vaccine hesitancy, and foster utilizing ‘houses of worship’ as vaccination sites.” At the summit, NIH Director Francis Collins claimed that the vaccines were provided by God. Faith leaders, explain the Thorps, were “unabashedly urged to ‘speak about the moral imperative of getting vaccinated in your sermons.’” Collins told “the faith leaders . . . what to say to their congregants. He [urged] them to reassure their ‘flocks’ that the COVID-19 vaccines are ‘safe’ . . . ‘95% effective,’ and God’s ‘answer to prayer.’ . . . Collins said that pushing the shots, ‘is a love your neighbor moment.’” Faith leaders “were admonished not to believe ‘conspiracy theories’ about ‘possible side effects’—which Collins falsely said were untrue.” Jeffrey Zients (then White House COVID-19 Response Coordinator who is now President Biden’s Chief of Staff) “implore[ed] faith leaders to jump on board with the government’s mission to get a shot in every arm—peppering his comments with religious language [such as] ‘spread this good news’ . . . Stealth Invasion

During the last four years, the world has been invited to come to the United States of America—illegally. It is true that some of these illegal immigrants are women, children, and families seeking a shortcut into the U.S. They are seeking what some call "economic asylum" and the chance for a "better life." But, as Spike Hampson, writing for the Brownstone Institute reports, "legitimate refugees, in all likelihood . . . represent less than 10% of the total." For "the past three years the border jumpers have started coming from all around the world [now representing] over 160 different countries. Most of them, by the way, are healthy, single, young men." We cannot be naïve. "This refugee epidemic is an orchestrated phenomenon, planned and supported by international organizations" such as the United Nations together with the U.S. government. Its purpose is not to "solve a refugee problem" or ameliorate the "suffering of displaced people." We cannot ignore the increased business of cartels where drug and child trafficking is concerned. The refugee invasion is "tearing apart our country; [therefore], the federal government—especially Homeland Security—should be publishing detailed statistics regarding daily, weekly, monthly, and cumulative numbers for illegal immigrants admitted into the U.S. There should be similar tabulations for deportations, gotaways, etc." There are no detailed statistics or tabulations.

Investigative reporter Leo Hohmann, writes, "You know we are in the final stages of an invasion when even the corporate media is reporting on the thousands of Chinese nationals streaming across the U.S. southern border. CBS's *60 Minutes* reports that the Chinese-owned social media platform TikTok is being used to aid and abet the invasion of America" by providing step-by-step instructions for hiring smugglers and detailed directions to a particular crossing point. Hohmann provides a video from Drew Hernandez who on February 5, 2024, uncovered

multiple encampments of military-age male invaders" in Jacumba, CA. On March 3, 2024, former Green Beret and war correspondent Michael Yon, provided video footage of the United Nations Camp in Darien, Panama. This camp, explains Yon, is called San Vicente by the locals, but it is actually "China Camp." Yon reports: "[I] watched the United States grow this terrorist camp. Realizing Darien Gap likely would become a main invasion route to USA, I have spent about six months in and around this area since Biden was installed. . . . There is no doubt in my mind that people who pass through this camp will become responsible for the deaths of countless Americans. You have never seen a more serious terrorist camp in your life. This camp is funded by the U.S. DHS [Department of Homeland Security] and others through front organizations such as U.N. Migration and HIAS refugees. . . . The government of Panama wants to close this camp but WEF [World Economic Forum], Chinese Communist Party, the U.S. Embassy in Panama, and others work to keep this open."

Hampson concludes, "For all its flaws and weaknesses, for all its corruption, the United States remains the final bastion for protection of individual rights. The system being imposed from the top down will inevitably sacrifice the will of the people to the globalist vision—and that will prove to be the essence of tyranny and a wellspring of untold suffering."
